16/36 Apologies

16/38 Minutes of the Parish Council Meeting held on 7 March 2016

16/39 Matters Arising

- 16/34 Neighbourhood Watch (NW) The Chair reported that whilst it was not thought that the Neighbour hood Watch representative had to be a Parish Councillor he had consulted with the Community Policing Team but thus far had not received a response. GP advised that if the Council was looking for a volunteer then Guy Parkinson might be interested. It was agreed that the Chair would speak with Guy once the situation had been clarified. (Action: Chair)
- 16/34 Agricultural vehicles; Weight/Speed restrictions SJ reported that he had been advised that agricultural vehicles are exempt from regulations regarding weight restrictions

16/41 Street Scene

SJ reported on a WC Highways meeting he had attended on the 12 April 2016:

The meeting was an update on the state of contracts and provision of services.

Contractors. There will be 3, one dealing with major projects (Taurus I think, didn't catch name), another for patching and highway repair (Ringway) and the in-house Landscape organisation for Parish and Town Council level action. The 2 new contractors will not be fully operational until Oct, they need to buy equipment, recruit and train/re-train employees. As a result the services provided will be reaction based until then, (My Wilts App/Clarence are therefore key to getting work done) after which work will be scheduled and Parish and Town Councils will be informed.

Parish Stewards. There will be Parish Stewards, 22 for the County, but still recruiting the final 8. They will take-over the Parish contact role and will liaise directly with the nominated Parish representative. Their capability is at the "man and a van" level, but their retention is positive; how often they will be out in Corsley remains to be seen, 22 is not many for the whole of Wiltshire. Parish Councils have been asked to fill out a priority list of jobs they wish to be completed by the Stewards; I will review when it is forwarded to the Clerk. The old Community Coordinators have been pulled back and will be responsible for assurance on the work carried out by the contractors.

Litter. £2.5m to be spent on A road and town litter picking. Indicated there would be also be some attempt on B roads.

Gully Emptying. There are 89000 gullies in the County, the contract is for the clearance of 59400. The Council is trying to develop a database of those which need clearing regularly to target the resource more efficiently.

Rural Verge Cutting. This will take place once a year. Additional cutting will take place to maintain highway visibility when reported.

Road Sweeping. Rural roads will be swept once a year; a new provision.

Signs. There is a very limited budget and replacement will be limited to where there is a statutory requirement. Intent is to have an allocation in 2017 to catch up.

SJ emphasised that problems on the ground must be reported on CLARENCE and the MYWILTS app. If a problem is not reported it does not exist! SJ will continue to monitor the reporting.

JW reported that the surface of the A362 by Acres was showing cracks. SJ agreed to mention this at the CATG meeting.

16/42 Broadband

The Chair reported that there was a planned closure of Deep Lane which is believed to be due to the installation of the fibre 'box' that will hopefully provide high speed broadband to at least part of the Parish. The Chair has been in contact with BT to establish whether this is in fact the case and to determine whether the additional 'modelling' that was spoken about has taken place and what progress is possible for the future. As yet there has been no response. It was agreed the Chair should follow this up. (Action; Chair)

JH reported that she had been made aware of a possible 'scam' relating to the provision of broadband in the village. The Chair agreed to mention this in his report for The Bridge. (Action: Chair)

16/43 Old School

Access across the Car park The Chair reported that he had contacted the new owners of the Old School and they had accepted a revised charging arrangement for the access - £50 per week. The new charge would be effective from 1st April.

Little Cuckoos Lease Negotiations The Chair reported that he and OH had met with representatives of Little Cuckoos to discuss a revised lease and the associated matters. The representatives of Little Cuckoos were going to consider the proposed revisions and come back to the PC.

The Clerk reported on a conversation held with an officer of Wiltshire Council on the technicalities of revising the lease.

(JH reported that she had become aware that there was some disquiet with what the PC had proposed. Following discussion it was agreed that the Chair should meet direct with those concerned and clarify what the PC was suggesting. (Action: Chair))
